TERMS & CONDITIONS FOR COLLECTION OF TAX IN RESPECT OF SHOOTING PRE-WEDDING VIDEOS IN ENTIRE DIU MUNICIPAL AREA

- 1. A Public Auction for the contract for collection of Tax in respect of shooting Prewedding videos in entire Diu Municipal area.
- 2. The Contract will be for the period of One Year from the date of issue of the Order.
- 3. The fees to be collected by the Contractor shall be as under:

- 4. No charges to be collected from the couples who are resident of Diu irrespective of the Photographer residence. The couple shall have to produce Aadhaar Card with Diu address on it as a proof of residence. However, if the Photographer is from Diu but the couples are not the resident of Diu then they shall have to pay the necessary charges.

- 6. The highest bidder has to deposit 10% of the offered amount as a Security Deposit (annual amount) within one day after issue of order in form of Fixed Deposit Receipt (FDR) in favor of "The Chief Officer, Diu Municipal Council, Diu".
- 7. If the first highest bidder fails to accept the agreement then the second highest bidder will have to hold an agreement. Otherwise, the security deposit will be forfeited. The second bidder will also have to pay the amount of security deposit as shown in Point No. 6.
